Due to sanitary restrictions, the audit was performed remotely as full annual audit. It took place from 2021-08-03 until 2021-08-06 and covered the period from 2020-07-25 until 2021-07-24. The slight difference in the dates of this period of time audit is linked to the sanitary situation over Europe at the time of the audit.

The audit was performed as a full audit and has been documented in a specific report.

The next assessment has to be successfully carried out before 2022-07-25 in order to issue a new audit attestation letter as stated in the corresponding certificates issued by LSTI.

The audit was performed according to the European Standards “ETSI EN 319 411-1, V1.2.2 (2018-04)” and “ETSI EN 319 401, V2.2.1 (2018-04)” as well as CA Browser Forum Requirements “EV SSL Certificate Guidelines, version 1.7.1” and “Baseline Requirements, version 1.6.7” considering the requirements of the “ETSI EN 319 403-1, V2.3.1 (2020-06)” and “ETSI TS 119 403-2 V1.2.4 (2020-11)” for the Trust Service Provider Conformity Assessment.

The audit was based on the following policy and practice statement documents of the TSP:

1. [CP] E-TUGRA Certificate Policy, version 4.8, as of July 2021
2. [CPS] E-TUGRA Certification Practice Statement, version 4.8, as of July 2021

The TSP named the Sub-CAs that have been issued by the aforementioned Root-CA, that are listed in table 1 and that been covered in this audit.

No major non-conformities have been identified during the audit.

In the following areas, non-conformities have been identified throughout the audit:

Findings with regard to ETSI EN 319 401:

- [REQ-7.9-02] Incident management process
- [REQ-7.9-09] Incomplete implementation process that can lead to a loss of traceability
- [REQ-7.12-02] Documentation shall be improved

- [OVR-5.1-03] Documentation shall be improved
- [OVR-6.9.2-03] Documentation shall be improved
- [REG-6.3.4-14] Documentation shall be improved
- [OVR-6.5.2-11] Documentation shall be improved
